TITLE OF AGENDA ITEM: BID - A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, ACCEPTING THE BID AWARDED BY THE STATE OF FLORIDA UNDER CONTRACT NUMBER 515-630-06-1 TO WESCO TURF SUPPLY FOR LAWN EQUIPMENT. (\$45,455.81)

REPORT IN BRIEF: The Public Works Department maintains 19 Bermuda Sports fields with mowers that are seven years old and are in need of replacement. The State of Florida has previously awarded a bid for the purchase of lawn maintenance equipment by Florida State Contract Number 515-630-06-1. The Public Works Department wishes to purchase from Wesco Turf Supply, INC, an authorized distributor of Toro Groundmaster 4500- D Fine Cut Rotary Mower, for a total cost of \$45,455.81. Funds for this purchase were derived from the sale of a Town owned Motor Grader and Street Sweeper.
