SUBJECT: Proposed Resolution - ADAPT Grant Fourth Year Funding

This resolution is to present the four year allocation of funding for the grant period of 1999-00. The total A.D.A.P.T. project amount for this fourth year cycle is \$63,258, which is \$50,765. to the Town of Davie, with a grant funding of \$38,074. and a required match of \$12,691. and Cooper City's funding amount of the project is \$12,493., including their match, which is funded by the City of Cooper City, as was done in the previous year.

RESOLUTION _____

A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, AUTHORIZING THE SUBMITTAL OF THE ADOLESCENT DRUG AND ALCOHOL PREVENTION AND TREATMENT PROGRAM (A.D.A.P.T.) GRANT APPLICATION TO THE BROWARD COUNTY COMMISSION ON SUBSTANCE ABUSE FOR FOURTH YEAR FUNDING UNDER THE FEDERAL ANTI-DRUG ABUSE ACT; PROVIDING FOR MATCHING FUNDS.

WHEREAS, Broward County will receive Federal Anti-Drug Abuse Act funds for programs designed to reduce drug use and abuse within the community; and

WHEREAS, the Broward County Commission on Substance Abuse has awarded funds for the Police Department's Adolescent Drug and Alcohol Prevention and Treatment Program (ADAPT) for the past three years as part of a four year funding cycle; and

WHEREAS, in the second year of funding the Cooper City Police Department became a component of this program; and

WHEREAS, the Davie Police Department is requesting funding for the fourth year of this program including the Cooper City Police Department's involvement; and

WHEREAS, the total funding being requested for this fourth year cycle is \$63,258., which is \$50,765. to the Town of Davie, with a grant funding of \$38,074. and a required local match of \$12,691. and Cooper City's funding amount of the project is \$12,493., including their match, which is funded by the City of Cooper City as was done in the previous year.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE, FLORIDA.

SECTION 1. The Town Council of the Town of Davie hereby authorizes the Mayor, Town Administrator and other appropriate Town staff to submit an application for Federal Anti-Drug Abuse Act funding to the Broward County Commission on Substance Abuse.

SECTION 2. That should the Town be awarded the grant, the cash match required as part of the grant shall be allocated in the FY 99-00 Budget for the Town of Davie.

SECTION 3. This resolution shall take effect immediately upon its passage and adoption.
