**SUBJECT:** Resolution

**TITLE OF AGENDA ITEM:**

A Resolution of the Town of Davie, Florida, authorizing the application in the amount of \$250,000 for funding of the COPS in schools for additional police officers under the Community Oriented Policing Program administered by the U.S. Department of Justice.

**REPORT IN BRIEF:**

- Continue partnership with the Broward County School Board.
- Expand the Town's Community Oriented Policing Program.
- Add two (2) additional full time School Resource Officers in Davie schools.

**DISCUSSION:** (include background, project summary, significant impacts, citizen participation, workload impacts, purpose, project workscope, evaluation and selection process, and conclusion)

This Resolution will authorize the application being submitted in the amount of \$250,000 for funding of the COPS in schools for additional police officers under the Community Oriented Policing Program. This proposed expansion of the Community Oriented Policing Program will benefit both the residents of our community and the schools located in the Town of Davie. We feel that the chances of us obtaining this grant are high due to our past experience of receiving grants from the Federal government. By receiving this grant, it will allow the Police Department to hire two (2) additional police officers to be employed as School Resource Officers working exclusively with the children within those Davie schools. The cost of this program over the three year term of the grant will be \$87,898.66 to the Town for the two (2) officers. In return the Town will receive \$250,000 to supplement the officers salaries. If the Town were to hire two (2) additional officers without this grant, it would cost the Town over the three year period \$337,898.66. The grant requires the Town to retain these two positions after the expiration of the grant.

A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, AUTHORIZING THE APPLICATION IN THE AMOUNT OF \$250,000 FOR FUNDING OF THE COPS IN SCHOOLS FOR ADDITIONAL POLICE OFFICERS UNDER THE COMMUNITY ORIENTED POLICING PROGRAM ADMINISTERED BY THE U.S. DEPARTMENT OF JUSTICE

WHEREAS, the Town of Davie Police Department currently receives grant funding for Community Oriented Policing Officers; and

WHEREAS, the Town, in partnership with the Broward County School Board, is proposing to expand the Town's Community Oriented Policing Program to include two additional full time Community Oriented Police Officers who will be assigned to the Town of Davie schools; and

WHEREAS, as a part of this program, the Town of Davie has committed to provide the required grant match and has also committed to retain these two Community Policing Officer positions at the conclusion of the grant cycle; and

WHEREAS, this proposed expansion of the Community Oriented Policing Program will benefit the residents of the community and the schools population of Broward County Schools located in the Town of Davie.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE, FLORIDA:

SECTION 1. The Town Council of the Town of Davie hereby authorizes the application for this grant funding and authorizes the Mayor to accept the grant if awarded.

SECTION 2. This resolution shall take effect immediately upon its passage and adoption.
