A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, AUTHORIZING THE TOWN OF DAVIE TO CO-SPONSOR AN ALTERNATIVE TO SUSPENSION PROGRAM ENTITLED JAGUAR EDUCATIONAL TRANSITION (JET) PROGRAM FOR THE PERIOD OF AUGUST, 1999 TO JUNE, 2000

WHEREAS, the Town of Davie previously awarded an agreement with Indian Ridge Middle School and the YMCA of Broward County by resolution R-98-260; and

WHEREAS, keeping youth involved in school and providing a positive learning experience with counseling is considered an important step in juvenile diversionary activities; and

WHEREAS, the Indian Ridge Middle School, the YMCA of Broward County and the Town of Davie desire to provide an Alternative to Suspension Jaguar Educational Transition (JET) Program at the Orange Park Community Center Monday through Friday from August, 1999 to June, 2000 at no cost to the sponsoring agencies.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE, FLORIDA.

SECTION 1. The Town Council of the Town of Davie does hereby acknowledge the co-sponsoring of the Alternative to Suspension Jaguar Educational Transition (JET) Program and hereby authorizes the site of Orange Park Community Center for the above program at no fee for the period of August, 1999 to June, 2000 during the weekday hours from 8:00 am to 3:00 pm.

SECTION 2. This resolution shall take effect immediately upon its passage and adoption.
