SUBJECT: Resolution

TITLE OF AGENDA ITEM: A resolution of the Town of Davie, Florida, authorizing the Mayor, Town Administrator and appropriate staff to accept the fourth year grant award under the Federal Anti-Drug Abuse Act for project ADAPT.

REPORT IN BRIEF: Acceptance of fourth year funding and award of the A.D.A.P.T. Program (Adolescent Drug Abuse Prevention and Treatment). This program is to help adolescent first time offenders to obtain help through counseling rather than being sent through the court system, thereby preventing a criminal record if possible.

PREVIOUS ACTIONS: This is the fourth year funding for the ADAPT Grant Award, which is in the amount of \$50,765.00 with our local match of \$20,760.00, making a total project cost of \$72,525. Resolution R-99-155 granted the approval for funding of the local match. This resolution is to request signatures on the Certification document. We have 30 days from the award date of 10/01/99, in which to execute and return the Certification of Acceptance of Subgrant Award.

A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, AUTHORIZING THE MAYOR, TOWN ADMINISTRATOR AND APPROPRIATE STAFF TO ACCEPT THE FOURTH YEAR GRANT AWARD UNDER THE FEDERAL ANTI-DRUG ABUSE ACT FOR PROJECT "ADAPT" (ADOLESCENT DRUG ABUSE PREVENTION AND TREATMENT PROGRAM).

WHEREAS, Resolution R-99-155 approved the application submittal and appropriation of the local match for the fourth year funding of the Adolescent Drug Abuse Prevention and Treatment Program through the Broward County Commission on Substance Abuse; and

WHEREAS, the grant requires execution of the Certification of Acceptance of Subgrant Award #00-CJ-D8-11-16-02-185 , in the amount of \$50,765., for the period of October 1, 1999, through September 30, 2000; and

WHEREAS, the grant requirement for the agreement between the Town of Davie, the City of Cooper City and Nova Southeastern University for the fourth year grant award has been met.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE, FLORIDA.

SECTION 1. The Town Council of the Town of Davie hereby authorizes the Mayor, Town Administrator and/or appropriate staff to accept the fourth year funding award of the Adolescent Drug Abuse Prevention and Treatment Program Grant.
