TITLE OF AGENDA ITEM:

A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, AUTHORIZING A DONATION OF \$58,000.00 TO THE DAVIE POLICE ATHLETIC LEAGUE FOR THE PURPOSES OF HIRING TWO RECREATION ATTENDANT

REPORT IN BRIEF:

The FY2001 budget contains funds for the hiring of 2 Recreation Leaders in the Police Department who were to work in the PAL program. Because the PAL desires to hire 2 people who are related, and, inasmuch as this would violate the Town's nepotism rules, and, insofar as the Town Attorney has opined that the Town cannot hire these relations within the same Department, it is recommended that the budgeted funds be given directly to PAL for the purpose of PAL hiring them as its employees.

PREVIOUS ACTIONS:

The Town Council has previously given \$15,000.00 from the Donations account and \$35,000.00 from Forfeiture Funds for FY2001. With this donation, the total contribution will be \$108,000.00.

A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, AUTHORIZING A DONATION OF \$58,000.00 TO THE DAVIE POLICE ATHLETIC LEAGUE FOR THE PURPOSES OF HIRING TWO RECREATION ATTENDANTS

WHEREAS, the Town approved two recreation leaders to work with the Davie Police Athletic League (PAL) in the FY2001 budget; and

WHEREAS, PAL desires to hire two residents who are related ; and

WHEREAS, the Town's personnel rules nepotism provisions would preclude the hiring of two related persons working in the same Department; and

WHEREAS, this change will have no financial impact on the Town; and

WHEREAS, to continue this program using those persons PAL desires to employ is in the best interests of the Town and that the Town believes it is better that PAL employ directly these relations as its own employees.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE, FLORIDA:

SECTION 1. The Town Council hereby approves a \$58,000.00 donation to the Davie Police Athletic League, with the stipulation that these funds be expended to cover the personnel costs of two recreation leaders who will be employees of PAL. This donation shall be taken from those Police Department personnel accounts into which these funds were originally budgeted.

SECTION 2. This resolution shall take effect immediately upon its passage and adoption.
