A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, APPOINTING _____ AS THE TOWN'S DESIGNEE TO THE STATE ROAD 7/US 441 AESTHETIC AND ECONOMIC DEVELOPMENT COMMITTEE; APPOINTING THE DEVELOPMENT SERVICES DIRECTOR AS THE TOWN'S STAFF MEMBER ALTERNATE TO THE STATE ROAD 7/US 441 AESTHETIC AND ECONOMIC DEVELOPMENT COMMITTEE, PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE

WHEREAS, the Town of Davie is located along the State Road 7/US 441 corridor;
and

WHEREAS, the Town is interested in the development of the State Road 7/US 441 corridor through the South Florida area; and

WHEREAS, the South Florida Regional Planning Council (SFRPC) is facilitating a State Road 7/US 441 Aesthetic and Economic Development Committee in an effort to represent the interests of all jurisdictions along the State Road 7/US 441 corridor relative to aesthetics and economic development; and

WHEREAS, the SFRPC has requested that each jurisdiction appoint an elected Official as a designee and an alternate to represent the jurisdiction interest; and

WHEREAS, the Town Administrator recommends that the Town appoint a designee and staff member alternate to the State Road 7/US 441 Aesthetic and Economic Development Committee; and

WHEREAS, the Town Council of the Town of Davie, Florida deems it to be in the best interest of it's citizens to appoint an elected official as the Town's designee and the Development Services Director as the Town's staff member alternate to the State Road 7/US 441 Aesthetic and Economic Development Committee.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE, FLORIDA.

SECTION 1. _____ is hereby appointed as the Town's designee to the State Road 7/US 441 Aesthetic and Economic Development Committee.
