TITLE OF AGENDA ITEM: A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, AUTHORIZING THE EXPENDITURE OF FUNDS FROM THE LAW ENFORCEMENT TRUST FUND FOR DONATION TO THE BROWARD COUNTY CRIME STOPPERS.

REPORT IN BRIEF: The Town of Davie Police Department would like to donate \$3,500.00 to the Crime Stoppers organization. The solicitation of the public's assistance in the location of suspected criminals has resulted in the arrest and conviction of many criminals who would otherwise remain at large. This supplemental funding is to be taken from the Law Enforcement Trust Fund and will enable the Broward County Crime Stoppers to continue their worthwhile endeavor.

RESOLUTION _____

A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, AUTHORIZING THE EXPENDITURE OF FUNDS FROM THE LAW ENFORCEMENT TRUST FUND FOR DONATION TO THE BROWARD COUNTY CRIME STOPPERS.

WHEREAS, Florida State Statute, 932.704, provides for the use of funds from the Law Enforcement Trust Fund for the purpose of criminal investigations; and

WHEREAS, the Broward County Crime Stoppers is a working and productive organization in its efforts to solicit the assistance of the public in the location and apprehension of criminals; and

WHEREAS, the cases pursued by the Broward County Crime Stoppers has resulted in the arrest and conviction of a vast number of criminals who would otherwise remain at large; and

WHEREAS, the Davie Police Department desires to provide supplemental funding in the amount of \$3,500.00 to the Broward County Crime Stoppers to be funded from the Law Enforcement Trust Fund, in accordance with Florida Statutes 932.704, which is not a recurring cost.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE, FLORIDA.

SECTION 1. The Town Council of the Town of Davie hereby agrees to expend \$3,500.00 to Broward County Crime Stoppers, to be appropriated from the Law Enforcement Trust Fund.

SECTION 2. This resolution shall take effect immediately upon its passage and adoption.
