TITLE OF AGENDA ITEM: A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, AUTHORIZING THE SUBMITTAL OF AN APPLICATION FOR FUNDS UNDER THE U.S. DEPARTMENT OF JUSTICE LOCAL LAW ENFORCEMENT BLOCK GRANTS PROGRAM FOR \$82,501, AUTHORIZING THE ACCEPTANCE OF SAID FUNDS, ALLOCATING THE REQUIRED MATCH FROM THE LAW ENFORCEMENT TRUST FUND, AND AUTHORIZING THE APPROPRIATE TOWN OFFICIALS AND STAFF TO IMPLEMENT SAID GRANT PROGRAM

REPORT IN BRIEF: The Bureau of Justice Assistance of the U.S. Department of Justice annually offers grant funding to those municipalities who are currently in the Local Law Enforcement Block Grants program. They are proposing \$82,501 in grant funding if we provide a local match of \$9,167, which will be utilized to address our local law enforcement needs in new technology. We recommend applying for the grant and funding the required match of \$9,167 from the Law Enforcement Trust Fund.

PREVIOUS ACTIONS:The Local Law Enforcement Grant is offered annually and must be applied for annually. An example is R-97-229, which was approved for grant funding with a local match and the grant monies were used to enhance the Community Oriented Policing Programs and additional laptop computers.

RESOLUTION _____

A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, AUTHORIZING THE SUBMITTAL OF AN APPLICATION FOR FUNDS UNDER THE U.S. DEPARTMENT OF JUSTICE LOCAL LAW ENFORCEMENT BLOCK GRANTS PROGRAM FOR \$82,501, AUTHORIZING THE ACCEPTANCE OF SAID FUNDS, ALLOCATING THE REQUIRED MATCH FROM THE LAW ENFORCEMENT TRUST FUND, AND AUTHORIZING THE APPROPRIATE TOWN OFFICIALS AND STAFF TO IMPLEMENT SAID GRANT PROGRAMS

WHEREAS, the Bureau of Justice Assistance of the U.S. Department of Justice is charged with implementing the Local Law Enforcement Block Grants Programs; and

WHEREAS, under this program the Town of Davie is allocated \$82,501 in grant monies which will be utilized for new technology; and

WHEREAS, the Local Law Enforcement Block Grant program requires a local match of \$9,167 to address local law enforcement needs; and

WHEREAS, the Davie Police Department wishes to expend \$9,167 for the local grant match from the Law Enforcement Trust Fund, in accordance with Florida Statute 932.7055(4c), which is not a recurring cost.

WHEREAS, NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE, FLORIDA.

SECTION 1. The Town Council of the Town of Davie hereby authorizes the submittal of a Local Law Enforcement Block Grant program application for funding in the amount of \$82,501 with a local match of \$9,167 from the Law Enforcement Trust Fund.

SECTION 2. The Town Council of the Town of Davie authorizes the appropriate Town officials and staff to execute all grant documents and implement the grant program upon the receipt of funds.

SECTION 3. This resolution shall take effect immediately upon its passage and adoption.
