A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, AUTHORIZING THE EXPENDITURE OF FUNDS FROM THE LAW ENFORCEMENT TRUST FUND TO SUPPLEMENT THE DAVIE CHILD SAFETY BOARD IN AN AMOUNT NOT TO EXCEED \$2,000.

WHEREAS, the Davie Child Safety Board is a working and productive organization in its efforts to assist the Town of Davie residents in the safety of our children; and

WHEREAS, the Davie Child Safety Board furnishes the children with helmets for both bicycle riders and horseback riders, printing and distributing of various flyers and leaflets promoting safety; and

WHEREAS, the Davie Police Department desires to provide supplemental funding for supplies, equipment and operational expenses in an amount not to exceed \$2,000 to the Davie Child Safety Board to be funded from the Law Enforcement Trust Fund, in accordance with Florida Statue 932.7055 (4c), which is not a recurring cost.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE, FLORIDA.

SECTION 1. The Town Council of the Town of Davie hereby approves to expend an amount not to exceed \$2,000 to the Davie Child Safety Board, to be appropriated from the Law Enforcement Trust Fund.

SECTION 2. This resolution shall take effect immediately upon its passage and adoption.
