A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, AUTHORIZING THE EXPENDITURE OF FUNDS FROM THE LAW ENFORCEMENT TRUST FUND FOR A DONATION TO BEAT THE HEAT, INC.

WHEREAS, Florida State Statute, 932.704 provides for the use of funds from the Law Enforcement Trust Fund for the purpose of education; and

WHEREAS, Beat The Heat, Inc. is a non-profit organization working to educate your people about the real problems of illegal drug and alcohol use as well as drag racing; and

WHEREAS, Beat The Heat Inc. is a "Cops and Kids" oriented program bringing the youth together with the police working jointly to make a difference within our community; and

WHEREAS, this funding will assist in the development of a representative vehicle to be used for programs geared to reach children within the Davie Community; and

WHEREAS, the Davie Police Department desires to provide supplemental funding in the amount of \$2,500 to Beat The Heat, Inc. to be funded from the Law Enforcement Trust Fund, in accordance with Florida Statute 932.704, which is not a recurring cost.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE, FLORIDA.

SECTION 1. The Town Council of the Town of Davie hereby approves to expend \$2,500 to Beat The Heat, Inc. to be appropriated from the Law Enforcement Trust Fund.

SECTION 2. This resolution shall take effect immediately upon its passage and adoption.
