We are requesting funding not to exceed \$15,000, from the Law Enforcement Trust Fund, to furnish future D.A.R.E. graduating students with items such as; medallions, tee shirts, pens, pencils, rulers, key chains and stickers for their efforts.

A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, AUTHORIZING FUNDS FROM THE LAW ENFORCEMENT TRUST FUND TO PURCHASE SUPPLIES FOR THE DRUG ABUSE RESISTANCE EDUCATION (D.A.R.E.) PROGRAM.

WHEREAS, the Davie Police Department is participating in the nationwide Drug Abuse Resistance Education (D.A.R.E.) Program for the fifth grade elementary students in Davie; and

WHEREAS, D.A.R.E. graduation essay winners are awarded medallions and D.A.R.E. tee shirts are given to each graduating student; and

WHEREAS, the Police Department wishes to expend an amount not to exceed \$15,000 for D.A.R.E. supplies for approximately 2,500 Davie fifth grade students, from the Law Enforcement Trust Fund, in accordance with Florida Statute 932.704, which is not a recurring cost.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE, FLORIDA.

SECTION 1. The Town Council of the Town of Davie hereby approves the purchase of D.A.R.E. supplies for the Davie fifth grade elementary students.

SECTION 2. The Town Council authorizes the expenditure of funds, not to exceed \$15,000, from the Law Enforcement Trust Fund.

SECTION 3. This resolution shall take effect immediately upon its passage and adoption.
