**TITLE OF AGENDA ITEM:** A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, REQUESTING SUPPORT AND COOPERATION FROM THE BROWARD COUNTY SCHOOL BOARD CONCERNING THE CONSTRUCTION OF AN ACCESS ROAD ADJACENT TO FOX TRAIL ELEMENTARY SCHOOL.

**REPORT IN BRIEF:** The Town's recently completed traffic study, performed by URS, identifies the area between Fox Trail Elementary School and the Davie Police Department located on South Nob Hill Road as an area of concern. To alleviate the traffic concerns in this area the Town would like to construct an access road to Eastbound State Road 84. To facilitate the completion of this project the Town is requesting the support and cooperation of the Broward County School Board so that the applicable right-of-way can be acquired.

WHEREAS, the Town of Davie has recently received a traffic study performed by URS Corporation which identified the area between Fox Trail Elementary School and the Davie Police Department located on South Nob Hill Road as an area of concern; and

WHEREAS, the Town would like to construct an access road to Eastbound State Road 84 from the aforementioned area to address the traffic concerns mentioned in the study; and

WHEREAS, the Town is seeking the support and cooperation of the Broward County School Board in facilitating the completion of this project by assisting with the acquisition of the applicable right-of-way.

NOW, THEREFORE, BE IT RESOLVED, THAT THE TOWN COUNCIL OF THE TOWN OF DAVIE, FLORIDA:

SECTION 1. That the Town Council of the Town of Davie does hereby request the support and cooperation of the Broward County School Board concerning the acquisition of the necessary right-of-way to complete the construction of an Eastbound access road to State Road 84 adjacent to Fox Trail Elementary School.

SECTION 2. That the Town Clerk is hereby directed to send a copy of this resolution to the Broward County School Board.

SECTION 3. This resolution shall become effective immediately upon adoption.
