TITLE OF AGENDA ITEM: A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, AUTHORIZING THE APPLICATION, ACCEPTANCE AND IMPLEMENTATION OF A GRANT FOR HISTORIC PRESERVATION OF THE VIELE HOUSE FROM THE FLORIDA DEPARTMENT OF STATE, DIVISION OF HISTORICAL RESOURCES, IN THE AMOUNT OF \$50,000 (WITH \$50,000 MATCHING FUNDS).

REPORT IN BRIEF: The FL Department of State, Division of Historical Resources, provides small matching grants of up to \$50,000 for historic preservation projects. The Viele House was built in 1912 and is one of Davie's oldest buildings. Within two years, the Viele property will be developed. To preserve the structure, the Town will move the Viele House to a site on the Old Davie School grounds. The Town will apply for a \$50,000 grant from the State to prepare the new site/foundation, to transport the house, and to install it at the new location. This project has a required local match that equals 50% of the total project cost (\$50,000 Davie match).

RESOLUTION _____

A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, AUTHORIZING THE APPLICATION, ACCEPTANCE AND IMPLEMENTATION OF A GRANT FOR HISTORIC PRESERVATION OF THE VIELE HOUSE FROM THE FLORIDA DEPARTMENT OF STATE, DIVISION OF HISTORICAL RESOURCES, IN THE AMOUNT OF \$50,000 (WITH \$50,000 MATCHING FUNDS).

WHEREAS, the Florida Department of State, Division of Historical Resources, provides grant funding for historic preservation projects; and

WHEREAS, the Viele House is a historic structure that was built in 1912 and was the home of one of Davie's pioneer families; and

WHEREAS, the Town of Davie wishes to obtain grant funding in order to preserve the Viele House by moving it to the Old Davie School grounds; and

WHEREAS, this is a matching grant program that requires a 50% local share of cost; and

WHEREAS, the Viele House will provide cultural and educational opportunities to Davie residents as part of the Old Davie School Museum.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE, FLORIDA.

SECTION 1. The Town Council of the Town of Davie hereby approves the Town Administrator and/or appropriate staff to submit an application for grant funding to the Florida Department of State, Division of Historical Resources for the preservation of the Viele House.

SECTION 2. The Town Council hereby authorizes the Town Administrator and/or appropriate staff to accept and implement the grant if awarded.

SECTION 3. This resolution shall take effect immediately upon its passage and adoption.
