A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, AUTHORIZING THE APPLICATION FOR A GRANT FROM THE FLORIDA EMS COUNTY GRANT PROGRAM FOR AUTOMATIC ELECTRIC DEFIBRILLATORS (AEDs); AUTHORIZING GRANT ACCEPTANCE AND EXECUTION IF AWARDED; AUTHORIZING AMENDMENT TO THE TOWN OF DAVIE OPERATING BUDGET TO RECOGNIZE GRANT REVENUE AND EXPENDITURES IF AWARDED (NO MATCH REQUIRED).

REPORT IN BRIEF: The Broward Regional EMS Council administers grants under the Florida EMS County Grant Program. These grants are designed to improve or expand pre-hospital EMS activities and services. Davie Fire Rescue is applying for a \$15,650 grant to purchase AEDs to be placed in Town facilities that are accessible to the public. AEDs will increase the survivability rate for patients in cardiac arrest and provide care before the arrival of rescue personnel. No local match is required for this grant.

A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, AUTHORIZING THE APPLICATION FOR A GRANT FROM THE FLORIDA EMS COUNTY GRANT PROGRAM FOR AUTOMATIC ELECTRIC DEFIBRILLATORS (AEDs); AUTHORIZING GRANT ACCEPTANCE AND EXECUTION IF AWARDED; AUTHORIZING AMENDMENT TO THE TOWN OF DAVIE OPERATING BUDGET TO RECOGNIZE GRANT REVENUE AND EXPENDITURES IF AWARDED. WHEREAS, the Broward Regional EMS Council administers grants funded by the EMS Trust fund under the Florida EMS County Grant Program; and

WHEREAS, projects funded through this program are designed to improve the quality of prehospital EMS activities or services, and/or to decrease patient mortality and morbidity; and

WHEREAS, Davie Fire Rescue wishes to apply for a \$15,650 grant to purchase AEDs; and

WHEREAS, this grant program does not require a local cash match;

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE, FLORIDA:

SECTION 1. The Town Council of the Town of Davie hereby authorizes the Town Administrator and/or appropriate staff to submit a grant application to the Florida EMS County Grant Program, and if awarded the grant, authorizes its acceptance and execution.

SECTION 2. The Town Council authorizes the Town Administrator and appropriate staff to execute said grant application, contract, and all grant documents.

SECTION 3. The Town Council authorizes an amendment to the Town of Davie FY2004 Operating Budget in order to recognize grant revenue and permit expenditures if the Town is awarded the grant.

SECTION 4. This resolution shall take effect immediately upon its passage and adoption.
