**TITLE OF AGENDA ITEM:** A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, ESTABLISHING A RESIDENT FAMILY SUMMER SEASON POOL MEMBERSHIP FEE FOR USE OF THE TOWN OF DAVIE SWIMMING POOLS.

**REPORT IN BRIEF:** In order to respond to the request for a membership fee specific to use of the Town's pool facilities by resident families during the school summer vacation months, staff recommends that a **Resident Family Summer Season Pool Membership Fee** of \$45 be established as follows:

1. Membership is valid for the months of June, July and August.
2. Membership allows use by up to (4) four members of a family: father, mother and two children; parent and three children, etc.
3. An additional fee of \$10 per individual is required for each additional individual in cases where there are more than (4) four members in a family.
4. Proof of residency (driver's license & current utility bill) and family relationship (birth certificate for each child) is required at time of membership registration.
5. Presentation of a valid membership card is required for admission to the pool deck area.
6. Valid for admittance during normal hours of operation for public use. Use may be restricted due to capacity limitations. Compliance with established Facility Use Policy and Rules and Regulations is required.

WHEREAS, the Town's existing Parks & Recreation Department fee schedule does not include a membership fee specific to resident family use during the school summer vacation break.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE, FLORIDA.

SECTION 1. The Town Council of the Town of Davie hereby establishes a Resident Family Summer Season Pool Membership Fee as stated in Exhibit "A".

SECTION 2. This resolution shall take effect immediately upon its passage and adoption.
