TITLE OF AGENDA ITEM: A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, AUTHORIZING THE SUBMITTAL OF AN APPLICATION FOR FUNDS UNDER THE U.S. DEPARTMENT OF JUSTICE LOCAL LAW ENFORCEMENT BLOCK GRANTS PROGRAM FOR \$22,524, AUTHORIZING THE ACCEPTANCE OF SAID FUNDS, ALLOCATING THE REQUIRED MATCH FROM THE LAW ENFORCEMENT TRUST FUND, AND AUTHORIZING THE APPROPRIATE TOWN OFFICIALS AND SAID STAFF TO IMPLEMENT SAID GRANT PROGRAM.

REPORT IN BRIEF: The Bureau of Justice Assistance of the U.S. Department of Justice annually offers grant funding to those municipalities who are currently in the Local Law Enforcement Block Grants program. They are proposing \$22,524 in grant funding if we provide a local match of \$2,503, which will be utilized to address our local law enforcement needs in new technology. We recommend applying for the grant and funding the required match of \$2,503 from the Law Enforcement Trust Fund.

RESOLUTION _____

A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, AUTHORIZING THE SUBMITTAL OF AN APPLICATION FOR FUNDS UNDER THE U.S. DEPARTMENT OF JUSTICE LOCAL LAW ENFORCEMENT BLOCK GRANTS PROGRAM FOR \$22,524, AUTHORIZING THE ACCEPTANCE OF SAID FUNDS, ALLOCATING THE REQUIRED MATCH FROM THE LAW ENFORCEMENT TRUST FUND, AND AUTHORIZING THE APPROPRIATE TOWN OFFICIALS AND STAFF TO IMPLEMENT SAID GRANT PROGRAMS.

WHEREAS, the Bureau of Justice Assistance of the U.S. Department of Justice is charged with implementing the Local Law Enforcement Block Grants Programs; and

WHEREAS, under this program the Town of Davie is allocated \$22,524 in grant monies which will be utilized for new technology and crime prevention/community relations programs; and

WHEREAS, the Local Law Enforcement Block Grant program requires a local match of \$2,503 to address local law enforcement needs, which is in accordance with Florida Statute 932.7055(4c), which is not a recurring cost.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE, FLORIDA.

SECTION 1. The Town Council of the Town of Davie hereby authorizes the Town Administrator and/or the Chief of Police to submit a grant application to the U.S. Department of Justice for the Local Law Enforcement Block Grant program requesting \$22,524 in grant monies and providing \$2,503 in matching funds.

SECTION 2. The Town Council authorizes the Town Administrator and/or the Chief of Police to accept and implement the grant and to execute all necessary grant contracts and documents.

SECTION 3. The Town Council authorizes the Director of Budget and Finance to recognize grant revenue and appropriate the required match into the appropriate departmental budget.

SECTION 4. This resolution shall take effect immediately upon its passage and adoption.
