TITLE OF AGENDA ITEM:

A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA CONCERNING THE HOLLYWOOD/FORT LAUDERDALE AIRPORT EXPANSION; ESTABLISHING EXPENSES FOR THE PROPOSED AIRPORT EXPANSION; PROVIDING THE TOWN TO PAY FOR 1/3 OF THE EXPENSES UP TO THE AMOUNT OF \$20,000 TO BE SHARED ALONG WITH THE CITY OF HOLLYWOOD AND THE CITY OF DANIA BEACH.

REPORT IN BRIEF: At an August 26, 2002 meeting of the Town Council, the Council agreed to share costs with the City of Dania Beach and Hollywood on issues relative to the expansion of the Ft. Lauderdale/Hollywood Airport. Since this meeting, The Town has submitted its share (\$17,161.21) of expenses to the City of Dania Beach.

The City of Dania Beach is seeking additional cost sharing reimbursement in the amount of \$11,792.88 for the period June, 2003 to June, 2004.

The attached resolution authorizes an additional expenditure amount not to exceed \$20,000 to be charged to the Town Administrator's department, after expending the aforementioned amount the balance will be \$8,207.12.

**A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA
CONCERNING THE HOLLYWOOD/FORT LAUDERDALE
AIRPORT EXPANSION; ESTABLISHING EXPENSES FOR
THE PROPOSED AIRPORT EXPANSION; PROVIDING THE
TOWN TO PAY FOR 1/3 OF THE EXPENSES UP TO THE
AMOUNT OF \$25,000 TO BE SHARED ALONG WITH
THE CITY OF HOLLYWOOD AND THE CITY OF DANIA
BEACH.**

WHEREAS, the Town agreed to pay one third of the cost to address various issues to update the socioeconomic study, and environmental impact study that would be incurred by the Town, the City of Hollywood, and the City of Dania Beach.

WHEREAS, The Town would need to contribute funds toward the legal costs that would be incurred by the Town, the City of Hollywood, and the City of Dania Beach.

WHEREAS, The Town has contributed seventeen thousand one hundred sixty dollars and twenty-one cents.

WHEREAS, the expansion of the Hollywood/Fort Lauderdale Airport will result in an increase in the amount of air traffic currently traveling over the Town; and

WHEREAS, the availability of funds for considering the effects of Hollywood/Fort Lauderdale Airport Expansion on the Town will be a benefit to the general public.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE, FLORIDA:

SECTION 1. The Town will remit cost sharing payment to the City of Dania Beach up to an additional twenty thousand dollars.

SECTION 2. Funding will be provided within the Town Administrator's department.

SECTION 3. That this Resolution shall take effect immediately upon its passage and approval.
