TITLE OF AGENDA ITEM: A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, ACCEPTING THE BID AWARDED BY THE TOWN OF DAVIE, RE-BID NO. B-02-92 TO "VILA & SON LANDSCAPING CORPORATION" FOR SUPPLY AND INSTALLATION OF AN IRRIGATION SYSTEM FOR LINEAR PARK.

REPORT IN BRIEF: Council approved resolution number R-2002-183 to accept the Bid from Gaskin Irrigation, who was the low bidder. Gaskin Irrigation was unable to perform their obligations under the contract and were replaced by the second lowest responsive and responsible bidder Vila & Son Landscaping Corporation. At this time, the Town would like to award well systems 1, 2, 3 & 4, which are the zones between Nob Hill Road and S.W. 148th Avenue. The recommendation is to award the bid to Vila & Son Landscaping Corporation, who has sent us a letter stating that they will honor their bid dated June 18, 2002.
