**TITLE OF AGENDA ITEM:** A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, AUTHORIZING THE APPLICATION FOR A \$10,000 GRANT FROM THE BROWARD BEAUTIFUL COMMUNITY GRANTS PROGRAM; AND AUTHORIZING ACCEPTANCE AND EXECUTION OF THE GRANT, IF AWARDED (WITH \$10,000 IN MATCHING FUNDS).

**REPORT IN BRIEF:** Broward Beautiful administers the Community Grants Programs to provide small grants to municipalities, non-profit organizations, and schools for landscape improvement projects. The Town will apply for a \$10,000 grant to landscape the Hiatus Road median near its intersection with State Road 84. This grant program requires a \$1 : \$1 match, so the Town needs to contribute \$10,000 toward the project. Irrigation systems and hardscape items, such as brick pavers, and not allowable expenses in this program.

A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, AUTHORIZING THE APPLICATION FOR A \$10,000 GRANT FROM THE BROWARD BEAUTIFUL COMMUNITY GRANTS PROGRAM; AND AUTHORIZING ACCEPTANCE AND EXECUTION OF THE GRANT, IF AWARDED (WITH \$10,000 IN MATCHING FUNDS).

WHEREAS, the Town of Davie wishes to beautify the community by enhancing the landscaping of the Hiatus Road median; and

WHEREAS, the Broward Beautiful Community Grants Program provides grants to municipalities and other organizations to fund landscape improvement projects; and

WHEREAS, it is in the best interest of the Town of Davie to seek grant funding toward the Hiatus Road landscape project and to provide the local matching funds that are required.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE, FLORIDA.

SECTION 1. The Town Council of the Town of Davie authorizes the Director of Public Works and/or appropriate staff to submit a grant application to the Broward Beautiful Community Grants Program requesting \$10,000 in grant funds and providing \$10,000 in matching funds.

SECTION 2. The Town Council authorizes the Director of Public Works and/or appropriate staff to accept and implement the grant, if awarded, and to execute all necessary grant contracts and documents.

SECTION 3. The Town Council authorizes the Director of Budget and Finance to budget \$20,000 for the project in FY 2006, and if awarded the grant, to recognize grant revenue and appropriate the required match into the appropriate departmental budget.

SECTION 4. This resolution shall take effect immediately upon its passage and adoption.
