TITLE OF AGENDA ITEM: A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, RECOGNIZING THE ENDLESS DEDICATION AND CONTRIBUTIONS OF CURTIS MANCINI TO THE TOWN OF DAVIE AS AN OFFICER AND AS A TRAINER AND ACKNOWLEDGING THESE CONTRIBUTIONS THROUGH THE RECOGNITION AND NAMING OF THE DAVIE POLICE DEPARTMENT BUILDING IN MEMORY OF OFFICER CURTIS MANCINI.

REPORT IN BRIEF: This is in recognition of Officer Curtis Mancini's dedication to the Davie Police Department. The naming of the Davie Police Department Building in honor of Officer Mancini will solidify his endless devotion and contributions he made to the Town of Davie. During his time as a police officer for the Town of Davie, Curtis Mancini was assigned as a detective to the Special Investigations Unit and worked directly with the DEA Task Force. During his tenure with the DEA Task Force, Officer Mancini confiscated nearly \$1,000,000.00 in seized assets that was later used to purchase the land that the Richard Marant Public Safety Complex resides on. In 2000, Officer Mancini returned to the Police Department and was assigned to the Professional Standards Unit as a Training Officer, where he assisted in the professional development of the police department personnel. In 2003, Officer Mancini was called to active military duty to serve in Operation Iraqi Freedom. In January 2004, Officer Mancini was re-deployed to Afghanistan assigned to mission Operation Enduring Freedom. On January 29, 2004, Officer Mancini was killed in the line of duty protecting his country and his community.

WHEREAS, in recognition of Officer Mancini's contributions to the Town of Davie, the Davie Police Department will memorialize Officer Mancini by naming the Police Department Building in his honor.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE, FLORIDA.

SECTION 1. That the Town of Davie hereby declares that the Davie Police Department Building will now and forever be known as the Curtis Mancini Building.

SECTION 2. The Town Council hereby authorizes this expenditure for dedication plaques, building markings and ceremony.

SECTION 3. This resolution shall take effect immediately upon its passage and adoption.
