TITLE OF AGENDA ITEM: A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, AUTHORIZING COUNCILMEMBER SUSAN STARKEY TO EXECUTE THE CONTRACT FOR THE POLICE FIRE MEMORIAL STATUE TO BE COMMISSIONED BY BRODIN STUDIOS, INC., AND AUTHORIZING A DEPOSIT OF \$50,000 TO BE SENT TO BRODIN STUDIOS, INC. FOR THE COMMENCEMENT OF CONTRACTED WORK.

REPORT IN BRIEF: Councilmember Starkey, Chairperson for the Davie Police and Fire Memorial Fund Committee, realized after 9/11 terrorist attack in New York City, Washington DC and Pennsylvania the need to recognize the Town of Davie Police and Fire Rescue personnel who have not only made the ultimate sacrifice, but also those who have served honorably for our community. Councilmember Starkey formed a committee to raise funds to erect a life size bronze memorial to be located in Bamford Park to be called the Davie Protectors. The committee has raised funding needed to begin the building of the bronze statue from Brodin Studios Inc. which is expected to take one year from date of contract.

A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, AUTHORIZING COUNCILMEMBER SUSAN STARKEY TO EXECUTE THE CONTRACT FOR THE POLICE FIRE MEMORIAL STATUE TO BE COMMISSIONED BY BRODIN STUDIOS, INC., AND AUTHORIZING A DEPOSIT OF \$50,000 TO BE SENT TO BRODIN STUDIOS, INC. FOR THE COMMENCEMENT OF CONTRACTED WORK.

WHEREAS, Councilmember Susan Starkey realized the need to recognize the Town of Davie Police and Fire Rescue personnel who have not only made the ultimate sacrifice, but also those who have served honorably for our community ; and

WHEREAS, Councilmember Susan Starkey formed a committee to raise funds needed to erect the bronze memorial statue; and

WHEREAS, the committee has raised funding needed to begin the building of the bronze statue from Brodin Studios Inc.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE, FLORIDA.

SECTION 1. That the Town of Davie hereby authorizes Councilmember Susan Starkey to execute the contract with Brodin Studios Inc.

SECTION 2. The Town Council hereby authorizes Councilmember Susan Starkey to expend from the Davie Police and Fire Memorial Account the funds needed for the deposit to begin construction of the memorial statue.

SECTION 3. This resolution shall take effect immediately upon its passage and adoption.
