TITLE OF AGENDA ITEM: A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, AUTHORIZING THE NAMING OF THE PARK LOCATED AT 5350 SW 58 AVENUE AS EAST DAVIE NATURE PARK.

REPORT IN BRIEF: The Town of Davie held a "Name the Park" contest in the fall of 2004 for the purpose of obtaining park name suggestions for the Town's eight new park sites. The Town's Open Space Advisory Committee reviewed the contest entries for this site and recommended three names for consideration by Town Council. The park name chosen by Town Council for the park site located at 5350 SW 58 Avenue is East Davie Nature Park.

A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, AUTHORIZING THE NAMING OF THE PARK LOCATED AT 5350 SW 58 AVENUE AS EAST DAVIE NATURE PARK.

WHEREAS, the Town of Davie is developing a Neighborhood Park located at 5350 SW 58 Avenue; and

WHEREAS, the Town needs and wishes to formally name this park site; and

WHEREAS, the Town conducted a "Name the Park Contest" to obtain resident input for the naming of its new park sites; and

WHEREAS, the park name East Davie Nature Park was a "Name the Park Contest" entry and was selected and unanimously approved as the official name for this park by Town Council at the April 20, 2005 Town Council Meeting.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE, FLORIDA.

SECTION 1. The Town Council of the Town of Davie hereby authorizes the park located at 5350 SW 58 Avenue be named East Davie Nature Park.
