TITLE OF AGENDA ITEM: A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, AUTHORIZING THE NAMING OF THE TOWN OF DAVIE PARK LOCATED AT 5695 SW 52 AVENUE AS SILVER LAKES ROTARY NATURE PARK.

REPORT IN BRIEF: The Town of Davie held a "Name the Park" contest in the fall of 2004 for the purpose of obtaining park name suggestions for the Town's eight new park sites. The Town's Open Space Advisory Committee reviewed the contest entries for this site and recommended three names for consideration by Town Council. The park name selected by Town Council for the site at 5695 SW 52nd Avenue is Silver Lakes Rotary Nature Park. Town Council selected this name (which was not a contest entry) to recognize The Rotary Club of Davie and Cooper City for its' generous contribution of a large shelter for the park.

PREVIOUS ACTIONS: At the April 20, 2005 Town Council Meeting the Town Council discussed the names for the park and agreed on Silver Lakes Rotary Nature Park.

A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, AUTHORIZING THE NAMING OF THE PARK LOCATED AT 5695 SW 52 AVENUE AS SILVER LAKES ROTARY NATURE PARK.

WHEREAS, the Town of Davie is leasing land located at 5695 SW 52nd Avenue from the Florida Department of Transportation for long term use as an Open Space Park for the outdoor recreational benefit of the public; and

WHEREAS, the Town needs and wishes to formally name this park site; and

WHEREAS, The Rotary Club of Davie and Cooper City generously donated a large shelter pavilion to the Town for the enjoyment and betterment of the community at this park site; and

WHEREAS, the Town Council desires to recognize and honor the charitable contribution of The Rotary Club of Davie and Cooper City; and

WHEREAS, The Town Council selected and unanimously approved the name Silver Lakes Rotary Nature Park for this site at the April 20, 2005 Town Council Meeting.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE, FLORIDA.

SECTION 1. The Town Council of the Town of Davie hereby authorizes the park located at 5695 SW 52 Avenue be named Silver Lakes Rotary Nature Park.

SECTION 2. This resolution shall take effect immediately upon its passage and adoption.
