TITLE OF AGENDA ITEM: A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, AUTHORIZING THE NAMING OF THE PARK LOCATED AT 2300 SW 71 TERRACE AS WES GRIFFIN PARK.

REPORT IN BRIEF: The Town of Davie held a "Name the Park" contest in the fall of 2004 for the purpose of obtaining park name suggestions for the Town's eight new park sites. The Parks & Recreation Advisory Board reviewed the contest entries for this site and recommended three names for consideration by Town Council. The park name chosen by Town Council for the park site located at 2300 SW 71 Terrace is Wes Griffin Park. Town Council selected this contest entry in order to recognize former Town of Davie Police Officer Wes Griffin by naming this park in his honor.

PREVIOUS ACTIONS: At the April 20, 2005 Town Council Meeting the Town Council discussed the names for the park and selected the name Wes Griffin Park.

A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, AUTHORIZING THE NAMING OF THE PARK LOCATED AT 2300 SW 71 TERRACE AS WES GRIFFIN PARK.

WHEREAS, the Town of Davie has developed a Neighborhood Park located at 2300 SW 71 Terrace; and

WHEREAS, the Town needs and wishes to formally name this park site; and

WHEREAS, the Town conducted a "Name the Park Contest" to obtain resident input for the naming of its new park sites; and

WHEREAS, the park name Wes Griffin Park was a "Name the Park Contest " entry and the Town Council wishes to recognize former Town of Davie Police Officer Wes Griffin by naming this park in his honor; and

WHEREAS, Town Council selected and unanimously approved the name Wes Griffin Park for this site at the April 20, 2005 Town Council Meeting.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE, FLORIDA.

SECTION 1. The Town Council of the Town of Davie hereby authorizes the park located at 2300 SW 71 Terrace be named Wes Griffin Park.

SECTION 2. This resolution shall take effect immediately upon its passage and adoption.
