TITLE OF AGENDA ITEM: A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, RATIFYING THE ACTIONS OF THE MAYOR IN DECLARING A STATE OF EMERGENCY WITHIN THE TOWN OF DAVIE DUE TO THE EFFECTS OF HURRICANE KATRINA; AND PROVIDING FOR AN EFFECTIVE DATE.

REPORT IN BRIEF: On Thursday, August 25, 2005, Mayor Truex declared a state of emergency within the Town of Davie due to the effects of Hurricane Katrina. Emergency Operations Center personnel manned the Center from August 25th to August 28th when the Mayor had declared the state of emergency had ended. This resolution aids the Town in its attempt to obtain reimbursement from FEMA for expenses relating to the hurricane.

A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, RATIFYING THE ACTIONS OF THE MAYOR IN DECLARING A STATE OF EMERGENCY WITHIN THE TOWN OF DAVIE DUE TO THE EFFECTS OF HURRICANE KATRINA; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Mayor declared a state of emergency Thursday, August 25, 2005; and

WHEREAS, in the evening hours of Thursday, August 25, 2005, South Florida, including the Town of Davie, was struck by the effects of Hurricane Katrina; and

WHEREAS, on Sunday, August 28, 2005, the Mayor declared that the state of emergency ended; and

WHEREAS, the Town of Davie sustained property damage from Hurricane Katrina; and

WHEREAS, the Town, in the interests of protecting the health, safety and welfare of the residents of the Town of Davie, has sustained expense in preparation for the hurricane and in clean up and debris removal after the storm passed; and

WHEREAS, the Town Council wishes to ratify the actions of the Mayor in his declaration of a state of emergency.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE, FLORIDA:

SECTION 1. That the Mayor's declaration of a state of emergency declared Thursday, August 25, 2005 through Sunday, August 28, 2005, is hereby ratified and affirmed and that this ratification shall be deemed effective as of Thursday, August 25, 2005 through Sunday, August 28, 2005.

SECTION 2. That this Resolution shall take immediately upon its passage and adoption.
