REPORT IN BRIEF: The Town Council awarded a contract to Larue Planning and Management Services, Inc. for miscellaneous planning services by Resolution R-2004-76. The initial contract period was two (2) years with options to extend the contract for two (2) additional one (1) year periods. The current contract period is scheduled to expire on April 17, 2006. The terms of the contract remain unchanged. The Development Services Department and the vendor wish to exercise the first option to extend the contract for one (1) additional year. If approved, the extension would cover the period of April 18, 2006 through April 17, 2007.
