REPORT IN BRIEF: The Town previously conducted and informal bid and awarded a contract for Fire Extinguisher Maintenance to Triangle Fire, Inc. That contract had a two year extension option, if agreed upon by both parties. Triangle Fire, Inc. has agreed to the extension with no price increase.

A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, APPROVING AN EXTENSION TO THE CONTRACT BETWEEN THE TOWN AND TRIANGLE FIRE, INC. FOR PORTABLE FIRE EXTINGUISHER MAINTENANCE.

WHEREAS, THE Town conducted an informal bid and awarded a contract for Portable Fire Extinguisher Maintenance to Triangle Fire, Inc.; and

WHEREAS, the terms and conditions of the contract allow for a two year extension by mutual agreement of the parties; and

WHEREAS, the Town and the contractor desire to extend the contract for and additional two years.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE, FLORIDA:

SECTION 1. The Town Council hereby approves the two year extension for the contract with Triangle Fire, Inc. for Portable Fire Extinguisher Maintenance.

SECTION 2. Funding shall come from account no. 001-0520-521-0430 Police Building Maintenance Fund, 054-0259-594-0430 Town Wide Building Maintenance / Interior and 001-0706-541-0329 Parks Building Maintenance Contractual.

SECTION 3. This Resolution shall take effect immediately upon its passage and adoption.


