The Town Council awarded the bid for these services to H&H Liquid Sludge Disposal, Inc. in January 2005 for a three year term with the option to renew for two additional one year periods. H&H has agreed to renew this contract with all conditions stipulated in the contract, including price, remaining the same. The Utilities Department would also like to recommend renewal of this contract.

A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, ACCEPTING THE BID FOR SEWER SLUDGE HAULING SERVICES.

WHEREAS, the Town is in need of sewer sludge hauling services for the Utilities Department; and

WHEREAS, the Town solicited sealed bids for such sludge hauling services; and

WHEREAS, after review, the Town Council wishes to accept the bid from H & H Liquid Sludge Disposal, Inc.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE, FLORIDA:

SECTION 1. The Town Council hereby accepts the bid from H & H Liquid Sludge Disposal, Inc. for sewer sludge hauling services in the amount of \$19.83/cu. yd. for dry sludge and \$67.82/1,000 gals. for liquid sludge for a total estimated cost of \$130,783.60/yr.

SECTION 2. The Town Council hereby authorizes the expenditure from the Utilities Department-Sludge Removal Account Number 040-1058-536-0426.

SECTION 3. The initial contract term is three (3) years with options to extend the contract for two (2) additional one (1) year terms by mutual agreement of the parties. Contract extensions, if appropriate, will be handled administratively by staff subject to budgetary approval by Town Council.

SECTION 4. This resolution shall take effect immediately upon its passage and adoption.
