COMMERCIAL ADDITION

***We require 2 sets of plans/surveys Packaged and stapled together.**

Required

- ___ Print out from the Broward County Property Appraisers Office (**WWW.BCPA.NET**)
- ___ **Zoning** (May require site plan review, consult with a planner)
(2 Original Sealed Surveys no older than 2 years)
Plot Plan (showing all intended setbacks from property lines and other existing structures)
Surveys must show all easements and encumbrances. Site plan modifications & parking calculations
- ___ **Landscape** (Can Be Incorporated on the Plot Plan) Signed and sealed by a landscape architect.)
- ___ **Engineering** 2 Complete sets of SWPPP to Comply W/ NPDES Required by FDEP
Drainage plan & cross section
Provide F.F.E. & B.F.E. on site plan and lowers equipment elevation
- ___ **Structural** (Truss plans\Shop Drawings (2 Complete sets, signed and sealed by eng., reviewed and signed by arch\Eng. of record)
(Product Approvals 2 complete sets reviewed and signed by Arch\eng of record.)
(Complete HVHZ Roofing application with notarized signature of contractor.)
(Letters of retention from insp. Firm that will be inspecting Eng. Unit Masonry and providing supervision of truss placement.) (Soil Compaction Letter) including bearing capacity
(2 complete sets, sealed by arch\Eng)
Product approval/truss/shop drawings/roofing applications maybe submitted at a later date, however this will result in an additional fee
- ___ **Electrical** (2 Complete Sets)
- ___ **Plumbing** (2 Complete Sets)
- ___ **Mechanical** (2 complete sets of plans) 2 complete sets of energy calculations sign by owner, project architect, or other officially designated agent.
2 Energy Performance Level (EPL) display cards signed by the building qualifier
- ___ **Utilities** Plans need to be reviewed and approved by Utilities Department prior to submittal to the building department (contact Heidi 954-327-3741)
- ___ Drainage district: (Stamped on Surveys or Plans)
Central Broward Water Control District
South Broward drainage district approval (if structure is in easement)
Tindall hammock approval
- ___ Department of Planning and Environmental Protection (Stamped on each set of plans bring in all forms they return)
- ___ Broward County Health Department Approval - If Sewage and water usage is with Septic Tanks or Wells (Stamped On Each Set of Plans * Bring In All Forms They Return)
- ___ Road paving fee or contribution agreement (Town Of Davie Engineering Dept.)
- ___ Utility service agreement (Town Of Davie Utilities if in Town Of Davie Service Area)
- ___ Completed building permit application - Please Note Plbg, Elect, Mech, Pools Are Separate Applications.
- ___ Contractors - A Copy of all applicable licenses (Competency/State & Occupation)
Copies Of Insurance Certificates for Workman's Comp and General Liability
- ___ Plan Check Fee in the amount of \$30.88 is required at time of submitting application permit.
