**REPORT IN BRIEF:** A competitive bid was conducted for the installation of a Roundabout at the intersection of Hiatus Road and SW 26<sup>th</sup> Street. The bid was sent to nine (9) bidders and also posted on the Town's web site. The Town received six (6) responses (5 bids & 1 "no bid response"). The recommendation is for Williams Paving Company, Inc. as the lowest responsive and responsible bidder for the base bid.
