REPORT IN BRIEF: The Town of Davie Police Department is requesting to donate \$1,000.00 to the Broward County Crime Stoppers organization. The solicitation of the public's assistance in the location of suspected criminals has resulted in the arrest and conviction of many criminals who would have otherwise remained at large. This supplemental funding is to be taken from the Police Department's Law Enforcement Trust Funds Account and will enable the Broward County Crime Stoppers to continue their worthwhile endeavor.

A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, AUTHORIZING THE EXPENDITURE OF FUNDS FROM THE LAW ENFORCEMENT TRUST FUNDS ACCOUNT IN THE AMOUNT OF \$1000.00 FOR A DONATION TO THE BROWARD COUNTY CRIME STOPPERS.

WHEREAS, the Broward County Crime Stoppers is a working and productive organization in its efforts to solicit the assistance of the public in the location and apprehension of criminals; and

WHEREAS, the cases pursued by the Broward County Crime Stoppers has resulted in the arrest and conviction of a vast number of criminals who would otherwise remain at large; and

WHEREAS, the Town of Davie Police Department is requesting approval to provide supplemental funding (donation) in the amount of \$1,000.00 to the Broward County Crime Stoppers to be funded from the Police Department's Law Enforcement Trust Funds.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE, FLORIDA.

SECTION 1. The Town Council of the Town of Davie hereby approves the donation of \$1,000.00 to the Broward County Crime Stoppers.

SECTION 2. The Town Council authorizes the expenditure in the amount of \$1,000.00 to the Broward County Crime Stoppers, to be appropriated from the Davie Police Department's Law Enforcement Trust Funds Account 001-0520-521-0316.

SECTION 3. This resolution shall take effect immediately upon its passage and adoption.
