TITLE OF AGENDA ITEM: CODE AMENDMENT - AN ORDINANCE OF THE TOWN OF DAVIE, FLORIDA, AMENDING THE TOWN'S BUSINESS TAX RATE SCHEDULE IN ACCORDANCE WITH CHAPTER 205.0535(4) OF THE FLORIDA STATUTES, BY INCREASING THE RATE OF EACH CLASSIFICATION BY FIVE PERCENT; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE. [requires supermajority vote]

REPORT IN BRIEF: Florida Statute 205.0535 sets forth the manner in which local governments may amend their Business Tax Receipt rate schedules. Because the Town has already complied with the provisions of Sections 205.0535(2) through (3), which involved the creation of an Equity Study Commission and the adoption of a "reclassification and revision ordinance", the Town may now revise fee categories and adjust the fee schedule by up to 5 percent every two years. The Town has made such adjustments every two years beginning in 1998 and last increased rates in June of 2006. The proposed ordinance will raise the business tax rates by 5 percent across all categories and creates some new categories as needed. Staff anticipates that a 5 percent increase in the rate schedule will generate an additional \$39,580 per year.

Because the Statutes allow this adjustment only every two years, the proposed increase would take effect October 1, 2008 and would not be applied retroactively. However, if the ordinance is approved, renewals mailed out on August 1st would reflect the new business tax rates. Note that, pursuant to Section 205.0535(4), this ordinance must be approved by a majority plus one.

AN ORDINANCE OF THE TOWN OF DAVIE, FLORIDA, AMENDING THE TOWN'S BUSINESS TAX RATE SCHEDULE IN ACCORDANCE WITH CHAPTER 205.0535(4) OF THE FLORIDA STATUTES, BY INCREASING THE RATE OF EACH CLASSIFICATION BY FIVE PERCENT; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, pursuant to Florida Statutes Chapter 205.0535, the Town of Davie's Business Tax Equity Study Commission reviewed the Town's Business Tax rate schedule and made recommendations concerning the rate schedule with such amendments being effective October 1, 1996; and

WHEREAS, Florida Statutes Chapter 205.0535(4) allows a municipality to adjust the Business Tax rate schedule by five percent every other year; and

WHEREAS, Council approved an increase on July 1, 1998 by Ordinance 98-31, on July 5, 2000 by Ordinance 2000-26 and on May 15, 2002 by Ordinance 2002-1, April 13, 2004 Ordinance 2004-14, June 2006 by Ordinance 2006-18; and

WHEREAS, the Town Council wishes to amend its Business Tax rate schedule pursuant to Florida Statutes.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE, FLORIDA:

SECTION 1. That each classification in the Business Tax rate schedule, attached hereto as Exhibit "A", is hereby increased by five percent as reflected thereon.

SECTION 2. This ordinance shall take effect for the tax period starting October 1, 2008.
