SUBJECT: Resolution

TITLE OF AGENDA ITEM: A resolution of the Town of Davie, Florida authorizing application, approval and execution for a grant from Broward County Florida for Swim Central Challenge Grant for SW 61st Avenue Park for \$200,000.

REPORT IN BRIEF: From the \$400 million Park bond funds which Broward County received, Broward County Parks and Recreation Division has offered \$15 million dollars in Swim Central Challenge Grants to municipalities and organizations in Broward. Grant projects must be aquatic related to the Swim Central Program. The Town has received a Land and Water Grant for the SW 61st Avenue Park which includes the plans for a heated swimming pool. The funding from Broward County Swim Central Challenge Grant would pay for the remaining cost for the swimming pool, fencing, security lighting, chemical control units, lifeguard chairs, safety equipment and signage, plus the deck. Because this grant application request is under \$201,000, no cash match is required.

RESOLUTION _____

A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA AUTHORIZING APPLICATION, APPROVAL AND EXECUTION FOR A GRANT FROM BROWARD COUNTY FLORIDA FOR SWIM CENTRAL CHALLENGE GRANT FOR SW 61ST AVENUE PARK FOR \$200,000.

WHEREAS, the Town of Davie and the Broward County Commissioners feel that drowning prevention is a priority for Broward County; and

WHEREAS, Broward County Swim Central Challenge grant funding is available for aquatic related projects to the Swim Central Program; and

WHEREAS, the Town has participated in the Swim Central program for two years at Pine Island Aquatic Complex; and

WHEREAS, the Town already received funding for \$144,472 for SW 61st Avenue Park from the Land and Water Conservation Fund Program; and

WHEREAS, the Town has requested authorization to submit application from Broward County Safe Parks and Land Preservation Challenge Grant for irrigation system, fencing, sodding sidewalks, benches, trash receptacles, bike racks, and increase the parking spaces, plus the remaining cost of restroom; and

WHEREAS, this grant application would complete the remaining cost of SW 61st Avenue Park heated swimming pool, pool fencing, security lighting, chemical control unit, lifeguard chairs, safety equipment and signage, plus paved pool deck at SW 61st Avenue Park; and

WHEREAS, this grant benefits all children in the Town and will help reduce the incidents of drowning in South Florida.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE, FLORIDA.

SECTION 1. The Town Council of the Town of Davie does hereby authorize the application, approval and execution by the Town for a grant from Broward County Swim Central Challenge Grant.

SECTION 2. Further, the Town Council authorizes the Mayor, Town Administrator and appropriate staff to execute said contract and all necessary documents.

SECTION 3. This resolution shall take effect immediately upon its passage and adoption.
