**TITLE OF AGENDA ITEM:** A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA REVISING THE FEE SCHEDULE FOR THE MEETING ROOMS AND PROVIDING FEES FOR RENTAL OF THE FACILITIES AT THE NEW PINE ISLAND MULTI-PURPOSE CENTER AND GYMNASIUM

**REPORT IN BRIEF:** The fee schedule for the meeting rooms was established by Resolution R93-221 on October 6, 1993, and Resolution R2000-228 on September 20, 2000. Staff is recommending revising the fee schedule in order to provide fees for the rental of the Towns new multipurpose/gymnasium building; to bring uniformity to the fee structure by regrouping the meeting rooms as small, medium or large according to capacity and effect a fee increase which is reflective of economic inflationary costs and supportive of the philosophy that user groups "pay for use" to help offset normal use related maintenance and personnel costs.

The proposed fees are comparable to those of the Towns neighboring communities. Comparable fee data consist of information obtained from a phone survey of neighboring communities fees and the Broward County Fee Survey dated February, 2001. Survey data is on file in the Town Clerk Office.

**PREVIOUS ACTIONS:**

**CONCURRENCES:** The Parks and Recreation Advisory Board approved the proposed fee schedule at the May 14, 2001, meeting except for the fees recommended for the Homeowner Associations, civic groups, clubs and non-profit groups. The Parks and Recreation Advisory Board deferred to the Town Council to determine the appropriate fees for Homeowner Associations, civic groups, clubs and non-profit groups.

WHEREAS, the Town Council, having legally advertised its intent to amend fees for these rental facilities and having presented opportunities for discussions and deliberation of these fees, wishes to revise fee schedule to encourage use of these facilities; and

WHEREAS, it is in the best interest of the Town of Davie to revise certain fees as attached hereto as Exhibit "A".

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE, FLORIDA.

SECTION 1. The Town Council of the Town of Davie does hereby adopt the revisions to the fee schedule, attached hereto as Exhibit "A".

SECTION 2. This resolution shall take effect immediately upon its passage and adoption.
