TITLE OF AGENDA ITEM: A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, AUTHORIZING THE EXPENDITURE OF FUNDS FROM THE LAW ENFORCEMENT TRUST FUND TO THE POLICE, FIRE AND MILITARY EQUIPMENT SHOW

A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, AUTHORIZING THE EXPENDITURE OF FUNDS FROM THE LAW ENFORCEMENT TRUST FUND TO THE POLICE, FIRE AND MILITARY EQUIPMENT SHOW

WHEREAS, the Davie Police Department is hosting the fifth Police, Fire and Military Equipment Show in Davie featuring the Safety Summit; and

WHEREAS, the Davie Police, Fire and Military Show will feature vehicles and equipment from local, state and national law enforcement agencies, and is in partnership with the School Board of Broward County and the Town's Child Safety Board; and

WHEREAS, the Davie Police Department desires to provide funding in the amount of \$3,500 to the Davie Police, Fire and Military Show, to cover program expenses, and to be funded from the Law Enforcement Trust Fund, in accordance with Florida Statute 932.7055 (4c), which is not a recurring cost.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE, FLORIDA:

SECTION 1. The Town Council of the Town of Davie hereby agrees to expend \$3,500 to supplement the Davie Police, Fire and Military Show to be appropriated from the Law Enforcement Trust Fund.

SECTION 2. This resolution shall take effect immediately upon its passage and adoption.
