A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, AUTHORIZING THE EXPENDITURE OF FUNDS FROM LAW ENFORCEMENT TRUST FUND TO THE TOWN OF DAVIE POLICE ATHLETIC LEAGUE.

WHEREAS, the Davie Police Athletic League is an organization designed to promote activities for the youth of the community as an alternative prevention to criminal activity; and

WHEREAS, funding is needed for the Police Athletic League to supplement the building budget; and

WHEREAS, the Police Department wishes to provide the Davie Police Athletic League with funding in an amount not to exceed \$100,000 from the Law Enforcement Trust Fund, for the purpose of purchasing furniture, fixtures and equipment (FFE), as a component of the construction budget, in compliance with Florida State Statute 932.704, which is not a recurring cost.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE, FLORIDA:

SECTION 1. The Town Council of the Town of Davie hereby agrees to expend an amount not to exceed \$100,000 from the Law Enforcement Trust Fund, to the Davie Police Athletic League for the purpose of purchasing furniture, fixtures and equipment in the construction of the new facility which will house the Davie Police Athletic League.

SECTION 2. This resolution shall take effect immediately upon its passage and adoption.
