WHEREAS, the TRIAD-SALT is an organization designed to promote activities for bringing seniors and law enforcement together; and

WHEREAS, the monthly meetings of the TRIAD-SALT is a countywide organization comprised of the Broward Sheriff's Office, local police departments and elder/retired leadership citizens who work together to reduce criminal victimization and improve public safety for older citizens; and

WHEREAS, the Police Department wishes to expend an amount not to exceed \$1,000 for Town of Davie representation to the National Association of Triads, Inc., 2001 Annual Conference, from the Law Enforcement Trust Fund, in compliance with Florida State Statute 932.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE, FLORIDA

SECTION 1. The Town Council of the Town of Davie hereby approves the expenditure, not to exceed \$1,000, for the TRIAD-SALT operations, activities and monthly meetings.

SECTION 2. The Town Council authorizes the expenditure from the Law Enforcement Trust Fund.
