**REPORT IN BRIEF:** The Fort Lauderdale Dog Club Inc wishes to donate \$5,692.00 worth of electrical improvements in the Bergeron Rodeo Grounds, at the expense of the Fort Lauderdale Dog Club Inc.. Once the electrical improvements are installed by a licensed electrical contractor, the electric improvements will become the property of the Town of Davie. The Town will give the Fort Lauderdale Dog Club Inc the opportunity to rent the Bergeron Rodeo Grounds for the next 5 years (2002-2007), on the third weekend in March, at each years applied rental rates.

**PREVIOUS ACTIONS:** The Town of Davie has accepted other capital improvement projects offered by other profit and nonprofit groups ( 5 star Rodeo and the Davie Rodeo Association) in past years.

**FISCAL IMPACT:** Once the electrical improvements are installed by a licensed electrical contractor, the electric improvements will become the property of the Town of Davie. This will save the Town the cost of \$5,692.00.

WHEREAS, the Town of Davie is desirous of working with nonprofit groups at the Bergeron Rodeo Grounds, of Davie Florida to present cultural and recreational events to the residents; and

WHEREAS, the Fort Lauderdale Dog Club Inc wishes to donate \$5,692.00 worth of electrical improvements in the Bergeron Rodeo Grounds, at the expense of the Fort Lauderdale Dog Club Inc ; and

WHEREAS, after the electrical improvements are installed by a licensed electrical contractor, the electric improvements will become the property of the Town of Davie:
