**TITLE OF AGENDA ITEM:** A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, OPPOSING THE FLORIDA DEPARTMENT OF TRANSPORTATION'S PLAN TO CONSTRUCT A MEDIAN ALONG PINE ISLAND ROAD THAT WOULD RESTRICT EAST-WEST TRAFFIC ALONG ORANGE DRIVE.

**REPORT IN BRIEF:** As part of ongoing improvements along the Griffin Road corridor the Florida Department of Transportation is proposing to construct a concrete separator along Pine Island Road between Griffin Road and Orange Drive. This median (separator) would span almost the entire length of the bridge running continuously until connecting to an existing median north of Orange Drive. The construction of this median would restrict east-west traffic along Orange Drive and would prevent motorists on northbound Pine Island Road from making a left turn and heading westbound on Orange Drive.

A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, OPPOSING THE FLORIDA DEPARTMENT OF TRANSPORTATION'S PLAN TO CONSTRUCT A MEDIAN ALONG PINE ISLAND ROAD THAT WOULD RESTRICT EAST-WEST TRAFFIC ALONG ORANGE DRIVE.

WHEREAS, as part of ongoing improvements along the Griffin Road corridor the Florida Department of Transportation is proposing to construct a median along Pine Island Road between Griffin Road and Orange Drive; and

WHEREAS, construction of this median would restrict east-west vehicular traffic along Orange Drive and would prevent motorists northbound on Pine Island Road from making a left turn and proceeding westbound on Orange Drive; and

WHEREAS, the Town of Davie believes that the proposed median would place an unnecessary burden on vehicular traffic and a potential safety risk for motorists traveling northbound on Pine Island Road attempting to proceed westbound on Orange Drive.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE, FLORIDA:

SECTION 1. That the Town of Davie hereby opposes the Florida Department of Transportation's plan to construct a median along Pine Island Road between Griffin Road and Orange Drive.

SECTION 2. The Town Clerk is directed to send a copy of this resolution to the Broward County Commission, the Metropolitan Planning Organization, and the Florida Department of Transportation.

SECTION 3. This resolution shall take effect immediately upon its passage and adoption.
