REPORT IN BRIEF: The Aplastic Anemia and MDS International Foundation, Inc. is in need of a location to hold a fundraiser on Saturday, October 26, 2002 from 12:00 p.m. to 6:00 p.m. Aplastic Anemia is a bone marrow failure disease that can strike any person of any age, gender or race anywhere in the world. One hundred percent of all monies donated to the Aplastic Anemia and MDS International Foundation, Inc. goes directly into medical research. The fundraiser will consist of costume contests for kids as well as a bounce house for enjoyment and an auction. The use of Robbins Lodge will not interfere with any planned Town program. The rental fee, which is being requested to be waived, is \$330.00. The Town of Davie is desirous of developing and maintaining relationships throughout the community for the benefit of the public. Staff recommends approval of the fee waiver request for use of Robbins Lodge for the stated purpose.
