TITLE OF AGENDA ITEM: A resolution of the Town of Davie, Florida, authorizing waiving of the facility rental fees in the amount of \$1,090 for use of the Gymnasium and Cypress Hall at Davie Pine Island Park Multipurpose Center on March 30, 2003 to host the Miss Davie Pageant.

REPORT IN BRIEF: Rebecca Stone, Miss Teen US Continental and Davie resident, has requested to use the Gymnasium and Cypress Hall at Pine Island Park on Sunday, March 30, 2003, from 9:00 a.m. to 6:00 p.m. to host the Miss Davie Pageant. The event will take place crowning six new Davie winners in the Tiny Miss, Little Miss, Junior Miss, Miss Junior Teen, Miss Teen, and Ms. Divisions. The rental fee for nine hours usage is \$70 per hour for Gymnasium (\$630), \$40 per hour for Davie based event for Cypress Hall (\$360), plus \$100 security deposit, which totals waiver fee of \$1,090. The only recreation program that would need to be canceled would be Open Gym Play.

A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, AUTHORIZING WAIVING OF THE FACILITY RENTAL FEES IN THE AMOUNT OF \$1,090 FOR USE OF THE GYMNASIUM AND CYPRESS HALL AT THE DAVIE PINE ISLAND PARK MULTIPURPOSE CENTER ON MARCH 30, 2003, TO HOST THE MISS DAVIE PAGEANT.

WHEREAS, Davie's own hometown girl, Rebecca Stone, Miss Teen US Continental, has been actively participating in youth pageants in Davie since the age of twelve; and

WHEREAS, Miss Davie Pageant will crown six new Davie winners in the tiny Miss, Little Miss, Junior Miss, Miss Junior Teen, Miss Teen Divisions, and the Ms. Division; and

WHEREAS, there will be no additional cost to the Town to host this pageant; and

WHEREAS, this event will spotlight the Town of Davie as a wholesome community that promotes programs for young women.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE, FLORIDA.

SECTION 1. The Town Council of the Town of Davie does hereby authorize the waiver of rental fees in the amount of \$1,090 to host the Miss Davie Pageant.

SECTION 2. This resolution, determined as being for the benefit of the young women of this Town, shall take effect immediately upon its passage and adoption.
