**TITLE OF AGENDA ITEM:** A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, AUTHORIZING THE APPLICATION, APPROVAL AND EXECUTION OF A GRANT FOR FUNDING FOR THE 2004/2005 CULTURAL YOUNG AT ART PROGRAM ADMINISTERED BY THE BROWARD CULTURAL COUNCIL, EDUCATION AND COMMUNITY DEVELOPMENT PROGRAM IN THE AMOUNT OF \$60,000.

**REPORT IN BRIEF:** The ECD (Education and Community Development Grant) is for \$30,000 with a 50% cash match of \$30,000, bringing the entire grant to \$60,000. The Parks and Recreation Department will transport approximately twenty children from four sites to the Young At Art Children's Museum for two eight week sessions. The facilities include Eastside Community Hall, Palma Nova Mobile Home Community Center, Orange Park/Boys and Girls Club and Rexmere Village. The children will receive, at no cost, two hours of art instruction, museum to go kits, and transportation to and from their site.

**PREVIOUS ACTIONS:** This is the fifth year that the Town of Davie Parks and Recreation Department has applied for funding from the Broward Cultural Council, Education and Community Development grant. Approximately 160 children ages 6-12 will be exposed to quality cultural opportunities by participating in this free program offered at four various locations throughout Davie.

A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, AUTHORIZING THE APPLICATION, APPROVAL AND EXECUTION OF A GRANT FOR FUNDING FOR THE 2004/2005 CULTURAL YOUNG AT ART PROGRAM ADMINISTERED BY THE BROWARD CULTURAL COUNCIL, EDUCATION AND COMMUNITY DEVELOPMENT PROGRAM IN THE AMOUNT OF \$60,000.

WHEREAS, the Town of Davie/Young at Art Program wants to significantly upgrade the cultural opportunities for the underserved communities in Broward County; and

WHEREAS, the Town of Davie will apply for funding from the Broward Cultural Council, Education and Community Development Program Grant as a governmental entity to enhance and increase the availability and quality cultural opportunities at four community recreational facilities by providing funding for two, eight week series of educational programs; and

WHEREAS, the Town must provide a 50% cash match for this Cultural Grant; and

WHEREAS, the Town is committed to the belief that the arts are a necessity in the development of contributing members of society, and the Town advocates and supports comprehensive arts education programming in Davie that increases awareness and understanding of the arts and artist in our society.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE, FLORIDA.

SECTION 1. The Town Council of the Town of Davie does hereby authorize the Mayor, Town Administrator and/or appropriate staff to submit an application for funding the Town’s Cultural-Young at Art Program.

SECTION 2. That the Town Council authorizes the Mayor to accept the grant if awarded and to execute the required match of \$30,000 for such program.

SECTION 3. The Town Council authorizes the expenditure from the Diversionary Latchkey Cultural Grant/Recreation account number 001-813-572-0585.

SECTION 4. This resolution shall take effect immediately upon its passage and adoption.
