TITLE OF AGENDA ITEM: A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, AUTHORIZING AND ACCEPTING THE STATE OF FLORIDA CONTRACT NUMBER 725-000-03-01 FOR THE PURCHASE OF WIRELESS CONNECTION SERVICE THROUGH VERIZON WIRELESS FOR THE LAPTOP COMPUTERS UTILIZED IN THE FIELD.

REPORT IN BRIEF: The police department has utilized AT&T Wireless CDPD connection for the laptop computers in the police cars so that the police officers can send police reports and conduct FCIC/NCIC checks on subjects during routine stops. This service is being discontinued by AT&T Wireless and needs to be replaced. The Police Department and Fire Services along with Technology and Information Management have reviewed and tested the new solutions offered by the submitting vendors. Based on the information obtained after field testing the vendor's proposals, the best solution for an optimal connection service is to use Verizon Wireless for the wireless connection service. The cost of the service will be \$59.99 per month for each modem. Funding has previously been appropriated for AT&T Wireless Service which is being discontinued.
