REPORT IN BRIEF: A competitive bid was conducted for providing dry cleaning services for Police and Fire Department uniforms. The Town sent out specifications to twenty-two (22) prospective bidders. Additionally, the bid was advertised state-wide in Florida Bid Reporting and nationally in BidNet and also posted on the Town's web site. The Town received four (4) bids. The recommendation is for Professional Cleaners as the lowest responsive and responsible bidder.

A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, ACCEPTING THE BID FOR DRY CLEANING OF POLICE AND FIRE DEPARTMENT UNIFORMS.

WHEREAS, the Town is in need of dry cleaning services for Police and Fire Department uniforms; and

WHEREAS, the Town solicited sealed bids for such dry cleaning services; and

WHEREAS, after review, the Town Council wishes to accept the bid from Professional Cleaners.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE, FLORIDA:

SECTION 1. The Town Council hereby accepts the bid from Professional Cleaners for dry cleaning services for Police and Fire Department uniforms in accordance with unit prices identified in Attachment "A".

SECTION 2. The Town Council hereby authorizes the expenditure from the Police and Fire Department-Uniform Accounts.

SECTION 3 The initial term is two (2) years with options to extend the contract for two (2) additional one (1) year terms by mutual agreement of the parties. Contract extensions, if appropriate, will be handled administratively by staff subject to budgetary approval by Town Council.

SECTION 4. This resolution shall take effect immediately upon its passage and adoption.
