REPORT IN BRIEF: Ms. Shelley Beck, Community Representative of the American Cancer Society's Davie/Cooper City Relay for Life Event has requested use of the Davie Pine Island Park Gymnasium and Cypress Hall on Sunday, February 6th, 2005, from 9:00 a.m. to 6:00 p.m. to host the Third Annual Miss Davie Pageant. Davie resident Rebecca Stone, Miss Teen US Continental 2003, has graciously offered her assistance with the preparation and presentation of this year's event which will result in the crowning of winners in the following eight divisions: Davie Miss, Tiny Miss, Little Miss, Junior Miss, Miss Junior Teen, Miss Teen, Miss and Mrs. Winners in the Miss Junior Teen, Miss Teen, Miss and Mrs. Categories are eligible to represent the Town in the July 2005 State of Florida Pageant. The amount of the rental and security deposit fee waiver request is \$1090. The only recreation program that would need to be canceled in order to stage this event is the Open Gym use.

A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, AUTHORIZING THE WAIVING OF RENTAL FEES FOR USE OF THE DAVIE PINE ISLAND PARK GYMNASIUM AND CYPRESS HALL ON FEBRUARY 6, 2005 TO HOST THE THIRD ANNUAL MISS DAVIE PAGEANT.

WHEREAS, The Town wishes to promote diversified wholesome life enriching activities for the young women of the community; and

WHEREAS, Davie's own hometown girl, Rebecca Stone, Miss Teen U.S. Continental 2003, coordinated the 2003 and 2004 Miss Davie Pageants and will again volunteer her time and efforts for the presentation of this year's event for the benefit of the American Cancer Society; and

WHEREAS, Pageant winners will be crowned in eight divisions from baby to adult with winners in the Miss Junior Teen, Miss Teen, Miss and Mrs. categories being eligible to advance as representatives of the Town at the State of Florida Pageant in July, 2005; and

WHEREAS, The Miss Davie Pageant is a local community benefit event sponsored by the American Cancer Society.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE, FLORIDA.

SECTION 1. The Town Council of the Town of Davie does hereby recognize the Miss Davie Pageant as a valued and beneficial event for the community.

SECTION 2. The Town Council of the Town does hereby authorize the waiver of rental fees in the amount of \$1,090 to host the Miss Davie Pageant.

SECTION 2. This resolution shall take effect immediately upon its passage and adoption.
