**TITLE OF AGENDA ITEM:** A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, REQUESTING THAT THE BROWARD COUNTY COMMISSION ADD 53.72 ACRES OF MULTIPLE CONTIGUOUS PARCELS UNDER TWO OWNERSHIPS IN WEST DAVIE TO THE LAND PRESERVATION OPEN SPACE INVENTORY FOR CONSIDERATION BY THE LAND PRESERVATION ADVISORY BOARD AND THE BROWARD COUNTY COMMISSION.

**REPORT IN BRIEF:** The Town is interested in preserving 53.72 acres of pasture land in west Davie and in seeking financial assistance from the Broward County Safe Parks and Land Preservation Bond Program toward its acquisition. The first step in this process is to request that the County Commission add the site to the program's land inventory.

No funding cycle is open however other municipalities have recently added parcels to the inventory.

A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, REQUESTING THAT THE BROWARD COUNTY COMMISSION ADD 53.72 ACRES OF MULTIPLE CONTIGUOUS PARCELS UNDER TWO OWNERSHIPS IN WEST DAVIE TO THE LAND PRESERVATION OPEN SPACE INVENTORY FOR CONSIDERATION BY THE LAND PRESERVATION ADVISORY BOARD AND THE BROWARD COUNTY COMMISSION.

WHEREAS, the Town of Davie has taken great strides to preserve its rural lifestyle in order to comply with the residents' stated desire to preserve open space; and

WHEREAS, the parcels with the folio #'s of 504021010310, 504021010330, 504021010331, 504021010340, 504021010350, 504021010400, 504021010410, 504021010420, 504021010421, 504021010430, 504021010440, located on Shotgun Road at approximately 36th Street, have been identified by the Town for preservation as open space; and

WHEREAS, Broward County, upon approval from its voters, created a \$ 200 million dollar fund to identify and preserve conservation areas and green spaces; and

WHEREAS, the Town of Davie wishes to seek financial assistance from Broward County to acquire and preserve these parcels.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE, FLORIDA:

SECTION 1. The Town of Davie hereby requests that the Broward County Commission add the parcels located on Shotgun Road to the land preservation inventory of open space parcels to be considered by the Land Preservation Advisory Board.

SECTION 2. The Town Clerk is directed to send a copy of this resolution to the Broward County Commission and the Land Preservation Advisory Board.

SECTION 3. This resolution shall take effect immediately upon its passage and adoption.
