WHEREAS, Viona Butler is a member of one of Davie's founding families, the Ware sisters; and

WHEREAS, unfortunately her home in eastern Davie is in dire need of repair and renovations; and

WHEREAS, her family has come to her aid by planning a fundraising effort at the Davie Police Athletic League facility to assist with the cost of materials to make the necessary repairs and renovations; and

WHEREAS, the Town recognizes that Viona Butler would be adversely impacted if Town permit fees for the repairs and renovations, and facility rental fees for the fundraising effort were charged.

NOW THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE, FLORIDA:

SECTION 1. The Town Council hereby waives all applicable permit fees for the repairs and renovations to the home of Viona Butler.

SECTION 2. The Town Council hereby waives all facility rental fees for the Davie Police Athletic League facility in relation to the fundraising effort for Viona Butler.

SECTION 3. This resolution shall take effect immediately upon its passage and adoption.
