SUBJECT: TU 8-3-05, Rick Case Hyundai Tent Sale

TITLE OF AGENDA ITEM: Temporary Use Permit for a promotional tent (canopy) sale at Rick Case Hyundai, 3550 Weston Rd., Davie, FL 33331

DISTRICT AFFECTED: District 4

REPORT IN BRIEF: The event consists of the special sales promotion for Rick Case Hyundai automobile dealership, to be held under a canopy within the parking area.

DURATION OF EVENT: The request is from Thursday, September 22, 2005 to Monday, September 26, 2005; from 9:00 AM to 9:00 PM Monday to Saturday, and 11 AM to 7 PM Sunday.

Section 12-319 of the Land Development Code requires that three (3) criteria be met for temporary use permits:

- 1) Any nuisance or hazardous features involved is suitably separated from adjacent uses;
- 2) Excessive vehicular traffic will not be generated on minor residential streets; and,
- 3) A vehicular parking problem will not be created.

Staff finds that the Rick Case Hyundai special promotion event-tent sale activities will be suitably separated from adjacent uses, there will be no traffic generated on minor residential streets, and a vehicle parking problem is not anticipated.

In addition the following conditions shall apply:

1. **Any temporary use authorized by Town Council shall be approved and accepted as to all terms and conditions by the applicant in writing within ten (10) days of the date such temporary use is authorized.** The applicant shall file such authorization with the Development Services Department.
2. This permit shall be valid from Thursday September 22, 2005 to Monday, September 26, 2005, daily between the hours of 9 AM to 9 PM, Monday to Saturday, and from 11 AM to 7 PM on Sunday.
3. Provide traffic barricades and parking direction personnel to assist customers entering the parking lot from Weston Rd. to avoid the pedestrian/canopy area.
4. The canopy area is to have no sides on the canopy. Fire extinguishers are to be provided at intervals of no greater than 50 ft. around the perimeter of the canopy. Fourteen rectangular tables, with chairs, are to be placed under the canopy configured

to provide for evacuation aisles in the event of emergency. There will be no food service under the canopy, and no open flames. Access to the site will be into the parking lot from Weston Rd. Distance from the closest building to the canopy is a minimum of 290 ft. No gates, fences, overhead wires, or vehicles are between, or permitted to be between, the entry from Weston Rd. and the canopy. The parking spaces immediately abutting the canopy to the west are to be cordoned off to provide emergency vehicle access (8 parking spaces to the west and south of the tent, and 5 spaces up to the designated handicapped-parking spaces to the west and north of the canopy).






TEMPORARY USE Zoning and Aerial Map


