TITLE OF AGENDA ITEM: A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, RATIFYING THE ACTIONS OF THE MAYOR IN DECLARING A STATE OF EMERGENCY WITHIN THE TOWN OF DAVIE DUE TO THE EFFECTS OF HURRICANE RITA; AND PROVIDING FOR AN EFFECTIVE DATE.

REPORT IN BRIEF: On Monday, September 19, 2005, Mayor Truex declared a state of emergency within the Town of Davie due to the anticipated effects of Hurricane Rita. Emergency Operations Center personnel manned the Center from September 19th to September 20th when the Mayor had declared the state of emergency had ended. This resolution aids the Town in its attempt to obtain reimbursement from FEMA for expenses relating to the hurricane.

A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, RATIFYING THE ACTIONS OF THE MAYOR IN DECLARING A STATE OF EMERGENCY WITHIN THE TOWN OF DAVIE DUE TO THE EFFECTS OF HURRICANE RITA; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Mayor declared a state of emergency on Monday, September 19, 2005; and

WHEREAS, between the evening hours of Monday, September 19 and the morning hours of Tuesday, September 20, 2005, South Florida, including the Town of Davie, was struck by the effects of Hurricane Rita; and

WHEREAS, on the afternoon of Tuesday, September 20, 2005, the Mayor declared that the state of emergency ended; and

WHEREAS, the Town of Davie sustained was spared from any significant property damage but did incur substantial costs related to emergency protective measures taken to mitigate any possible effects from Hurricane Rita; and

WHEREAS, the Town, in the interests of protecting the health, safety and welfare of the residents of the Town of Davie, has sustained expense in preparation for the hurricane and in clean up and debris removal after the storm passed; and

WHEREAS, the Town Council wishes to ratify the actions of the Mayor in his declaration of a state of emergency.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE, FLORIDA:

SECTION 1. That the Mayor's declaration of a state of emergency declared Monday, September 19, 2005 through Tuesday, September 20, 2005, is hereby ratified and affirmed and that this ratification shall be deemed effective as of Monday, September 19, 2005 through Tuesday, September 20, 2005.

SECTION 2. That this Resolution shall take immediately upon its passage and adoption.
